

# **DISPATCH SERVICE AGREEMENT**

This Dispatch Service Agreement ("Agreement") is entered into on this day of, 20, by and between:
Reign OTR Dispatch LLC, a Missouri limited liability company ("Dispatcher"), and , a motor carrier duly authorized to engage
n interstate and/or intrastate commerce under USDOT/MC Number:
"Carrier").

# 1. Scope of Services

Dispatcher agrees to provide freight dispatch services, including but not limited to: locating, booking, and scheduling freight loads for Carrier; communicating with shippers and brokers; assisting with load documentation; and invoicing Carrier for commissions. Carrier agrees to provide freight transportation services with its own equipment, drivers, and authority.

# 2. Commission and Payment Terms

Dispatcher shall receive a commission of 8% of the gross earnings from completed loads, calculated before deduction of Carrier's business expenses. Invoices shall be issued weekly on Friday and must be paid in full no later than Sunday end of day (48-hour grace period). Failure to pay will result in immediate pause of Dispatcher's services and possible termination of this Agreement. Legal action may be pursued to recover unpaid earnings.

#### 3. Exclusivity

Carrier agrees this is an exclusive dispatching relationship and shall not engage with another dispatch company until this Agreement is properly terminated.

## 4. Non-Solicitation of Brokers/Shippers

Carrier shall not bypass Dispatcher by conducting business directly with any broker, shipper, or customer introduced by Dispatcher. Violation could make Carrier legally liable for all earnings from such transactions.

### **5. Non-Compete with Employees**

Carrier shall not employ or contract with Dispatcher's current or former employees, agents, or contractors for six (6) months after this contract termination. Violation could make Carrier liable for compensation of all earnings made by violating parties.

#### 6. Term and Termination

This Agreement remains in effect until terminated. Dispatcher may terminate at any time without notice if Carrier is in violation of any terms of this Agreement. Carrier may also terminate at any time with seven (7) days written notice.

### 7. Liability Disclaimer

Dispatcher is not liable for freight damage or loss, vehicle damage, accidents, driver negligence, injuries, insurance claims, or compliance issues. Dispatcher is not responsible for any Carrier business expenses, including but not limited to: fuel, maintenance, tolls, insurance, factoring fees, employee costs, payroll, leases, inspections, compliance, taxes, lumper fees, legal costs, lodging, food, detention, or equipment costs.

### 8. Independent Contractor Relationship

This Agreement does not create a partnership, joint venture, or employment relationship. Carrier is solely responsible for its operations, drivers, and compliance.

#### 9. Governing Law

This Agreement shall be governed by the laws of the State of Missouri.

### 10. Entire Agreement

This document represents the entire agreement between the Parties and supersedes all prior agreements or understandings.
